



SELECTION CALL FOR A POSTGRADUATED RESEARCH SCHOLARSHIP.

“Study of the neurocognitive mechanisms of selective visual attention”

Art. 1

Institutions and fundings

A selection is now open for the conferral of n.1 post-lauream Research Scholarship to support the research project **“HowBEST - How the Brain deals with Emotional Stimuli”** financed by the project **CUP B34I19002710003, project CARIVR CHELAZZI BANDO 2018.**

Art. 2

Duration, Amount e Recipients

The post-lauream Research Scholarship, for a total amount of euros 12.000 (Twelve thousand euros) including any charges borne by the institution and the recipient, will have a duration of 12 months starting from 1 October 2022, it will be renewable and is intended for candidates who, at the time of the deadline for submitting applications, must fulfil the following requirements:

- Master's Degree in Psychology, Medicine and Surgery, Biology or similar;
- Previous research experience in fields related to integrative neurophysiology and cognitive neuroscience;
- Knowledge of the English.

Art. 3

Research activities

The research scholar will collaborate to the research project **“HowBEST - How the Brain deals with Emotional Stimuli”**, headed by the Principal Investigator, Prof. Leonardo Chelazzi, at the Section of Physiology and Psychology of the Department of Neuroscience, Biomedicine and Movement of the University of Verona.

Art. 4

Principal investigator

The Principal Investigator of the present research is Prof. Leonardo Chelazzi.
The research activities will take place at the sites defined by the Principal Investigator.

Art. 5

Selection Committee

The Scholarship will be awarded at the unquestionable judgment of the Selection Committee, constituted as follows:

Art. 6

Selection procedure

Applications for participation, written in plain paper and addressed to the Rector of the University of Verona, will be sent to one of the following offices:

- Protocol office: sent by e-mail (ufficio.protocollo@ateneo.univr.it), by fax (045 8028568) or certified e-mail;

not later than 12.00 on 23.08.2022

In the application, the candidate must attach:

- Educational qualification
- curriculum vitae
- any other documentation useful to prove the fulfillment of the requirements in Art.2.

With reference to the documentation referred to in points sub a) and sub c), candidates may produce a substitutive declaration of certification and / or substitute for the deed of notoriety pursuant to art. 46 and 47 D.P.R. 445 of 28/12/2000. For this purpose, candidates may use the form attached to this call. It should be noted that, in case of presentation of documentation in photocopy, conformity with the original must be declared using the above form.

Applications received after the deadline will not be taken into consideration and will result in exclusion from the call. In the case of sending applications by postal service, the stamp of the post office of dispatch will not be valid.

In the application, the candidate must declare: surname and name, place and date of birth, tax code, residence and address elected for the purposes of the call.

Art. 7

Verification of research results

At the end of the scholarship, the research scholar may submit a report describing the research activities carried out during the scholarship, allowing the evaluation of the scholar's work.

Art. 8

Selection and conferral

The Selection Committee will proceed to evaluate the titles (Art. 2) presented by the candidates. The Selection Committee will meet on **14.09.2022 at 12.00**, in the Dept. of Neuroscience, Section of Physiology and Psychology, Istituti Biologici, Strada Le Grazie 8, 37134 Verona

Points for qualifications and experience will be allocated as follows:

Only candidates who have achieved a score of 50 points will be admitted to the interview.

At the end of the work, the Committee will write a report with the criteria, the motivated results of the evaluation and the ranking. The report is immediately enforceable.

The scholarship is awarded on the basis of the merit ranking drawn up by the Committee and through the communication to the winning candidate by the Department of Neuroscience, Biomedicine and Movement. The winning candidate must contact the Principal Investigator to plan the beginning of the activity and the competent offices to sign the scholarship acceptance documentation. In the case of non-acceptance or forfeiture by the person entitled, those who follow them in the merit ranking drawn up by the Selection Committee take over.

If the Department fail, for any reason whatsoever, to obtain, in whole or in part, the funding intended for the payment of the Scholarship, the Director of the Department reserves the right, at its sole discretion, to suspend the disbursement of the same scholarship to the beneficiary, or not to proceed with the assignment.

Art. 9

Contract and insurance

The scholarship does not establish a subordinate employment relationship with the University and with the scholarship lender.

The scholarship does not provide welfare and social security treatments.

The scholarship is subject to the tax withholdings provided for by Italian law.

The scholar is insured against the risks deriving from third party liability and accidents, within the limits set by the general policy of the University.

Art. 10

Payment modalities

From the month of the beginning of the scholarship, 90% (ninety percent) of the scholarship will be paid on a monthly basis, net of withholding tax, taking into account any deductions and / or deductions due pursuant to law.

The remaining 10% (ten percent) of the amount will be paid after the submission of the final report of the activity carried out by the scholar.

Art. 11

Rights and duties of the scholar

The scholar has the right to access the research facility to which he/she is assigned and to use the services available to researchers in accordance with the facility regulations.

The research activity will be carried out inside the structure as well as outside it, where necessary and with the express authorization of the Principal Investigator.

At the end of the scholarship, the scholar must submit a scientific report on the activity carried out. The scholar must also submit, in the manner and within the time required, any intermediate reports (Art. 7) at the request of the Principal Investigator.

In the case of publication of the results of the research carried out during the scholarship, the author must indicate the assignee and the funding bodies of the scholarship through which the research was carried out.
