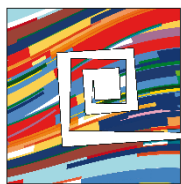

- ❏ Where provided for in the **specific call conditions**,
- ❏ applicants **may include** in their proposals the possible contribution of the JRC
- ❏ but the JRC **will not participate** in the **preparation** and **submission** of the proposal.
- ❏ Applicants will indicate the contribution that the JRC could bring to the project based on the scope of the topic text.
- ❏ After the evaluation process, the JRC and the consortium selected for funding may come to an **agreement on the specific terms** of the participation of the JRC.
- ❏ If an agreement is found, the JRC would **accede to the grant agreement** as **beneficiary** requesting **zero funding** and would accede to the consortium as a member”

 - The proposed actions must **not duplicate or replace** dissemination and exploitation activities that are part of the initial R&I projects. Proposed actions should go beyond such actions aiming at knowledge transfer and exchange.

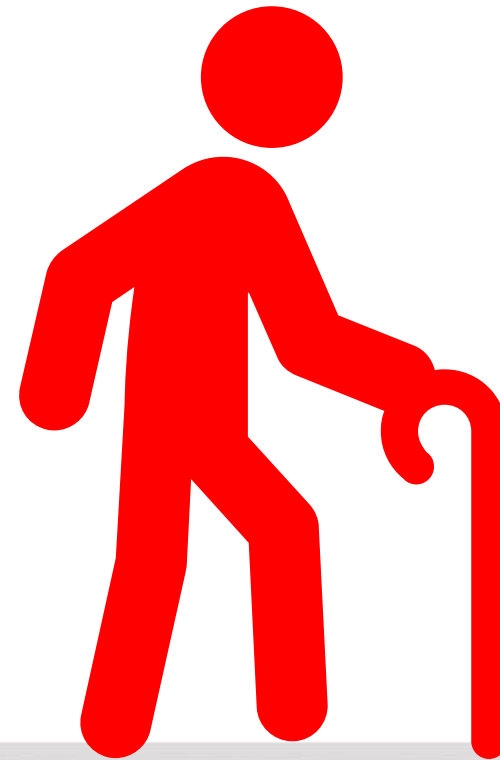

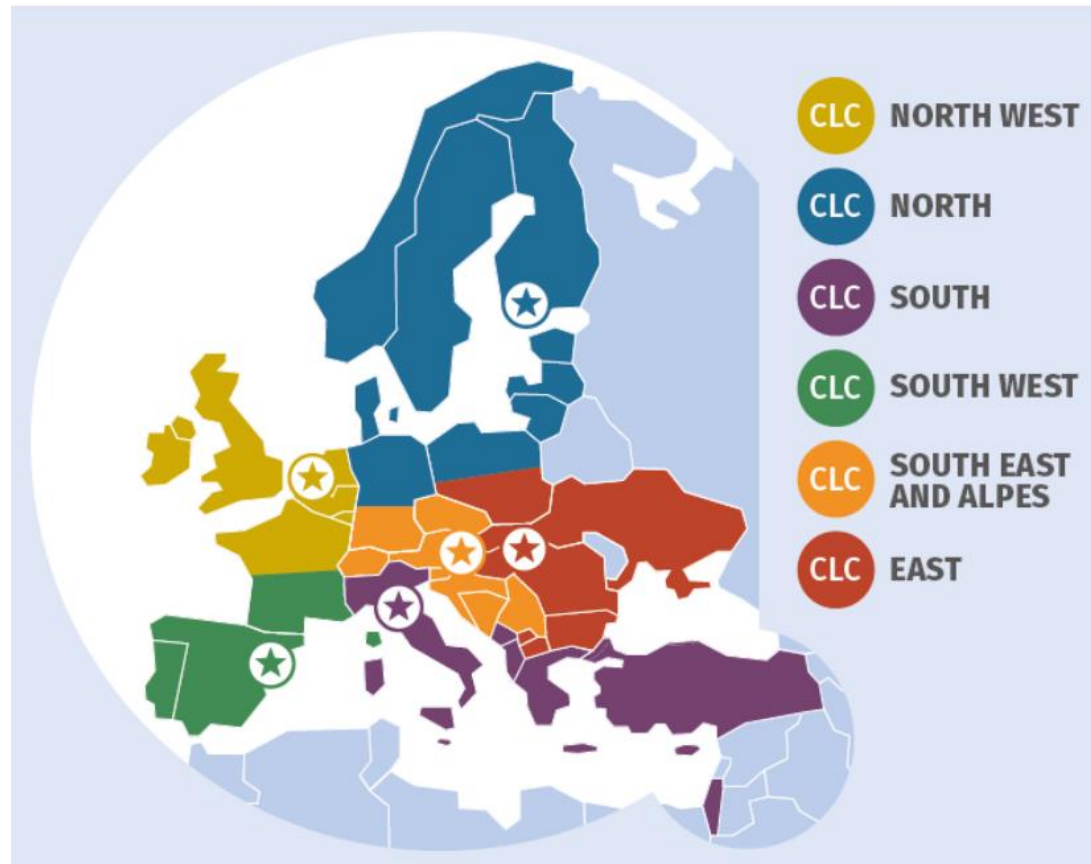
