PAOLA DI NICOLA, is Professor in the SSD SPS/08 Sociology of cultural and communication processes and is member of the Human Sciences Department of the University of Verona.

University researcher since 1988 at the University of Molise, in 1998 she was called by the University of Verona with the role of associate professor. She qualified as an ordinary professor in the academic year 2000-2001, and in this role she carried out research and teaching activities at the University of Verona.

Theoretical and empirical research activities

Paola di Nicola has developed three main lines of theoretical and empirical research, interconnected and interrelated, especially on the side of empirical repercussions.

The first line of research focused on structural and relational changes in the family, starting from the second half of the 1950s; line of research that resulted in the publication of two introductory manuals to the analysis of family changes: one of content and the other methodological. The dynamics of change were analyzed in the light of the most relevant demographic factors (birth, fertility, aging of the population), economic, juridical and cultural (processes of deinstitutionalization and privatization of family relationships). The analysis focused on the changes occurred in the couple relationship, in intergenerational relationships, in the forms of parenting with the consequent birth of new family configurations.

The second line of research focused on the theme of the connection between new family needs and welfare policies. The family is still one of the most important mechanisms for the redistribution of resources and the transmission of inequalities between the sexes and the generations. It is a mechanism whose functioning is strongly influenced by the presence or absence of welfare policies to de-familiarize needs, which can lighten the burden of reproductive work and decrease the dependence of the quality of life of social actors from the type of family they belong to. Within this research line, particular attention was paid to the policies of reconciliation between productive work and reproductive work, the persistent inequality in the division of domestic work and care between men and women, the functional overload of women with children and in pairs, at the limits of conciliation policies geared exclusively to women.

Third line of research: The increasing isolation of the conjugal family together with the processes of reform of welfare systems that have taken the path of passive subsidiarity of families and communities of belonging, have represented an excellent laboratory for observing the empirical effects of the analysis of broader social dynamics in the light of the network paradigm. The theoretical deepening of the network paradigm, in its theoretical genesis, as a 'metaphor' of a society founded on contractual exchanges, emotionally 'cold' and electives has allowed, with the methodological support of network analysis, to study how, empirically , the networks of interpersonal relationships have changed, as the forms and contents of the support networks have changed, giving rise to new forms of social capital (primary and secondary).
