COURSE CATALOGUE	All the mandatory undergraduate courses are taught in Portuguese, but there are also some electives taught in other languages, which vary each semester. The courses of each program can be found on https://www.ufcspa.edu.br/english/undergraduate-programs
NUMBER OF COURSES PER SEMESTER	International students must take at least 180 hours of classes.
GRADING SYSTEM	10-point scale, 7 points being the minimum score required for approval, and 6 points after a final exam. Minimum attendance of 75% is required. "Article 157. The student who fulfills the following criteria is considered approved in the course: I – Attendance equal to or greater than 75% of scheduled activities,
	reaching a final average equal to or greater than 7.0 (seven); II – Attendance equal to or greater than 75% of classes taught, reaching, after the final exam, an average equal to or greater than 6.0 (six), as a result of applying the formula: Final average after the exam = [(Average in the course × 6) + (Final exam grade × 4)] / 10



	§ 1 The student who has obtained an attendance equal to or greater than 75% and an average lower than 7.0 (seven) and equal to or greater than 4.0 (four) will be eligible to take the exam. § 2 The averages are calculated to two decimal points without rounding. § 3 The student who does not achieve the results set out in sections I and II of the caput of this article will fail the course."
LANGUAGE REQUIREMENTS	Portuguese level B1 is highly recommended. Students must send, until the beginning of the exchange, proof (certificate or letter from International Office or professor) that they have enough knowledge of Portuguese to attend the classes. In any case, the participation in the Portuguese classes offered by UFCSPA for free is mandatory (4h/week).

APPLICATION PROCEDURE AND ADMISSION

APPLICATION PROCEDURE	The institution of origin must send the student's application to UFCSPA by e-mail (mobilidadeacademica@ufcspa.edu.br).
	The information required is the following: - Cover letter from the home university; - Application form and statement of commitment (a document in which prospective students agree to UFCSPA's codes and the conditions for exchange, as set by the programs or agreements their mobility may be linked to);
	 - Passport copy; - Transcript of records signed by the home university; - Student motivation letter; - 3x4 picture.
APPLICATION DEADLINES	May 31 st (2 nd semester of the current year);
ADMISSION	October 31 st (1 st semester of the following year); UFCSPA will send the acceptance letter, via e-mail and, if necessary, by mail, to the students once the application has been accepted by the corresponding program.
	The student, if a foreign citizen, must send, up to two weeks before arrival:
	 Proof of language skills (Portuguese); Health insurance valid throughout the exchange period, covering repatriation of remains and Covid-19 related diseases; Copy of student visa (VITEM-IV); Copy of flight tickets.



	It is also highly recommended that the student issue and provide the CPF number before arriving in Brazil.
